Yurok Tribe hereby engages Contractor to provide services in accordance with the July 23, 2011, Proposal for Services (attached as Exhibit A) and to provide additional work related to Phase 1 Carbon Project verification support, including finalization of any modeling reports and documents.]

- 7. Compensation. Contractor's compensation for the Project shall be \$56,475, payable upon submitting timely invoices per terms of the Service Agreement. In addition to this amount, Contractor shall be compensated at the non-technical hourly rate of \$85 per hour for up to \_\_\_\_\_ hours of office visit verification support work and finalization of modeling reports, such total hours not to be exceeded without written approval from the Yurok Tribe Office of Tribal Attorney. Contractor shall be solely responsible for all costs incurred in connection with the accomplishment of the Project. Upon receiving each invoice for this contract, the Yurok Tribe Fiscal Department shall have 30 calendar days to process payment.]
- 3. Any capitalized term that is not expressly defined in this Amendment shall have the same meaning as it has in the original Contract Agreement.
- 4. Except as modified or amended herein, no other changes or modifications to the Contract Agreement are intended or implied and in all other respects the Contract Agreement is hereby specifically ratified, restated and confirmed by Yurok Tribe and Contractor. The Contract Agreement and this Amendment shall be read and construed as one agreement and shall remain in full force and effect.
